

- * 1 Schooling allowance: A system that provides assistance for educational expenses, such as school supplies, when it is difficult for a child to attend school due to economic reasons.
- * 2 Welfare assistance/ seikatsuhogo: A system that ensures a minimum standard of living and provides assistance to help individuals become self-reliant when they are unable to sustain their livelihood due to illness, accidents, or various other circumstances.
- * 3 Support and consultation center for individuals in financial distress: A consultation service that provides support for individuals facing diverse challenges in their lives, including financial difficulties, unemployment, and housing issues. Dedicated support staff collaborates with relevant institutions to develop personalized support plans and assist in resolving these challenges.
- * 4 Child-support allowance/ jidofuyo-teate: An allowance provided to single-parent households with income below a certain level to support their livelihood. (Different from child allowance/ jido-teate.)
- * 5 Employment and independence support center for single parents: A support center where single parents can receive counseling for finding a job and training on a job. Consultation is also available regarding child support payments/ yoikuhhi, etc.
